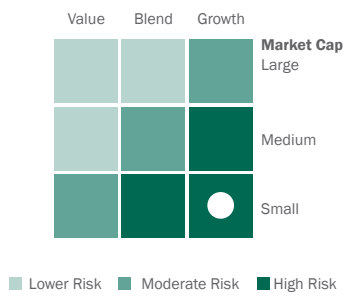


### Equity Investments

## Philosophy

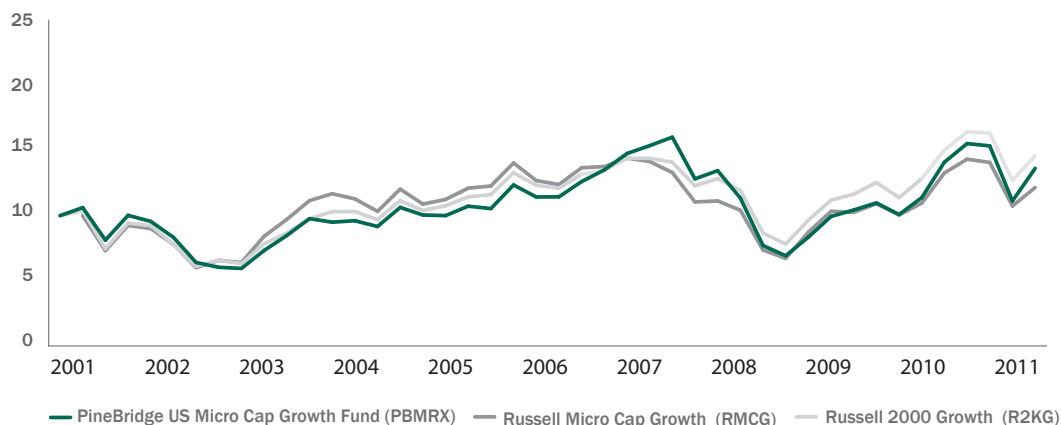
We believe the market is inefficient and our goal is to identify earnings growth in micro cap growth companies before it is reflected in the stock price.

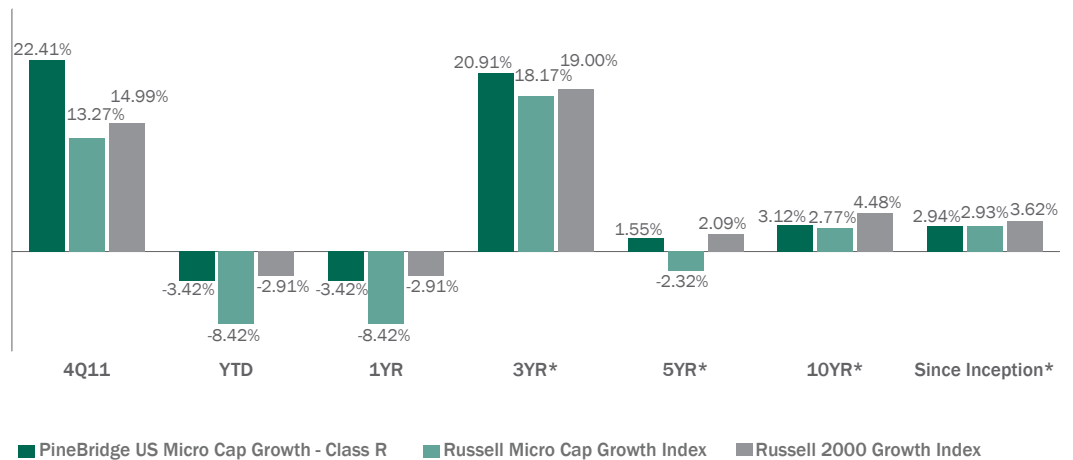

PE Ratio - The Price to Earnings Ratio (P/E) is a measure of value for a company. ROE - A measure of a corporation's profitability, calculated by dividing net income by total shareholder's equity. Debt to Capitalization Ratio - D/C ratio shows the proportion of a company's debt to its total capital, which consists of the sum of its debt and equity combined.

Russell 2000 Growth Index measures the performance of those Russell 2000 companies with higher price-to-book ratios and higher forecasted growth values. You cannot invest directly in an index.

The Russell Microcap Growth Index measures the performance of the microcap growth segment of the U.S. Equity market. It includes those Russell Microcap Index companies with higher price-to-book ratios and higher forecasted growth values.
