Objective

The investment objective of the PineBridge US Small Cap Growth Portfolio is to provide maximum capital appreciation, consistent with reasonable risk to principal.

Philosophy

We believe the market is inefficient and our goal is to identify earnings growth in smaller capitalization growth companies before it is reflected in the stock price.

Process

We employ a bottom-up approach, driven by fundamental equity research and assess earnings growth to select companies we feel have the most upside potential. We continuously and rigorously study company developments, including business strategy, management focus and financial results, to identify prospective companies.

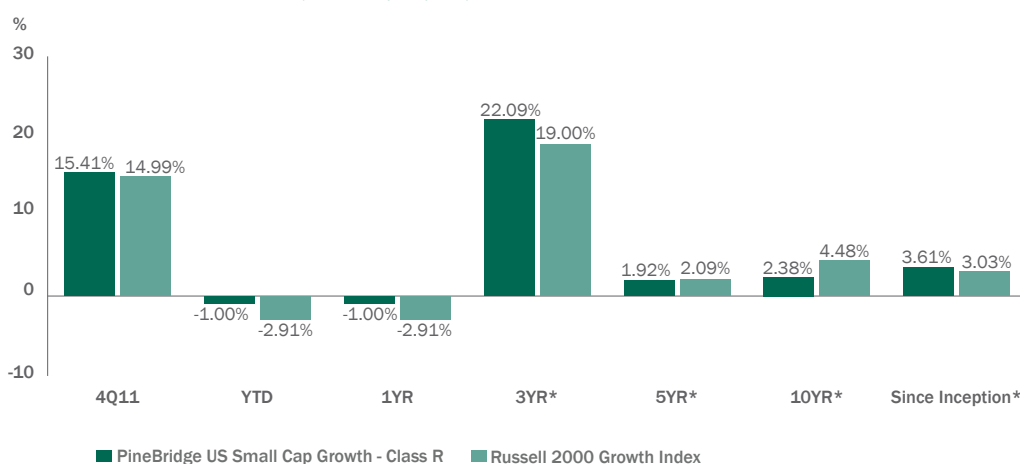

Debt to Capitalization Ratio - D/C ratio shows the proportion of a company's debt to its total capital, which consists of the sum of its debt and equity combined.

Russell 2000 Growth Index measures the performance of those Russell 2000 companies with higher price-to-book ratios and higher forecasted growth values. You cannot invest directly in an index.
