## What is this product?

### Type

UCITS investment fund in the form of an authorised unit trust.

### Term

The Sub-Fund has no maturity date, however the Manager is entitled to terminate the Sub-Fund at any time.

### Objectives

The Sub-Fund seeks to provide long-term capital growth by primarily investing mainly in equity (i.e. shares) and equity-related securities of companies listed on stock exchanges in the People's Republic of China ("PRC") or related to the economic development and growth of PRC.

In constructing the portfolio, the Investment Manager takes advice from the Investment Advisor on suitable investments. In recommending investments, the Investment Advisor uses a multi-factor quantitative model to rank investments in the Investment Advisor's investment universe. This multi-factor quantitative model utilises a number of fundamental based signals, which may include total enterprise value based on earnings or changes in earnings, the quality of earnings expectations, market momentum and management behavior. The Investment Manager, applying its own quantitative screening process, will determine if these recommended investments meet the Investment Manager's criteria for the Sub-Fund.

At least two-thirds of the Sub-Fund's total assets will be invested directly or indirectly in equities and equity-related securities of companies listed on stock exchanges in PRC, specifically China A-Shares. The Sub-Fund may invest up to 100% of its total assets in China A-Shares via the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and/or the qualified foreign investor(s) ("QFI") scheme.

Within the remaining one-third, the Sub-Fund may invest in transferable securities, in particular equity and equity related securities of (i) companies domiciled or with their registered office or primary place of business in PRC, (ii) holding companies that are predominantly invested in companies domiciled or with their registered office or primary place of business in PRC, (iii) companies with either the predominant part of their business operations or revenues derived or are expected to be derived from PRC, or (iv) companies which are listed on any approved Recognised Exchanges in PRC or Hong Kong.

The Sub-Fund may use financial derivative instruments ("FDI") for efficient portfolio management (including hedging) purposes only. The Sub-Fund will not use FDI extensively for any purpose.

**Share Class Benchmark** The benchmark is MSCI China A International Total Return Net Index.

**Benchmark** The Sub-Fund is actively managed, in reference to a benchmark. Many of the securities in the Sub-Fund may also be

represented in the benchmark because the Investment Manager uses it as a basis for portfolio construction, but the Investment Manager has some discretion to deviate from the benchmark composition and risk characteristics within certain risk parameters. Examples of this are being aware of and constraining differences in sector, country or constituent weightings between Sub-Fund and benchmark. These constraints will vary over time and are subject to change. The Investment Manager does not target a specific tracking error for the Sub-Fund but historically, tracking errors have ranged from 1-4%. This is subject to change at all times.

Though the Sub-Fund may share some composition and risk characteristics with the Sub-Fund's benchmark, the Investment Manager's discretion may result in performance that differs from that of the Sub-Fund's benchmark.

**Redemption and Dealing** This Unit Class of the Sub-Fund may be redeemed on demand on any dealing day as detailed in the supplement. The price you pay or receive depends on the net asset value per unit on the dealing day when the unit is bought or sold.

**Distribution Policy** This Unit Class seeks to pay out stable distributions consisting of income, gains and, potentially, capital as set out in the prospectus and supplement of the Sub-Fund. Distributions from capital may amount to a re-payment out of your original investment. Over time this could lead to the reduction or complete exhaustion of your holdings in the Unit Class. You may elect to receive payments of, or reinvest, the distributions from your units.

### Intended retail investor

The Sub-Fund is intended for investors who wish to invest in shares and equity-related securities of companies in China, who can bear loss in the short to medium term and have a medium to long term investment horizon, who plan to remain invested for at least 5 years. Investors should be prepared to take on the level of risk identified in the section, 'What are the risks and what could I get in return?' The Sub-Fund is designed to form part of a broadly diversified portfolio of investments, particularly for investors with little past experience of this type of investment.

## What are the risks and what could I get in return?

### Risks



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that

the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of PineBridge Investments Ireland Limited to pay you.

## What happens if PineBridge Investments Ireland Limited is unable to pay out?

## What are the costs?

## Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,

- 10,000 RMB per year is invested.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

The Sub-Fund is designed for investors with a with a medium to long-term investment horizon; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period at the prevailing net asset value, or hold the investment longer. If you redeem at an early stage this will increase the risk of lower investment returns or a loss.
